Property & Evidence

No Operation Medicine Cabinet items were collected in June. Total prescription and over-the-counter medication collected for 2015 is 169.0 pounds. These items will be incinerated at a later date.

The Property and Evidence section received 40 items in June, bringing the 2015 total intake to 285 logged items. No items were disposed of by destruction during June.

The total inventory for the Property and Evidence section through June 30, 2015 is 3,750 logged items, with a total quantity of 11,406 items.

Beach Patrol

Seventy-nine unique events including 37 Police or Community Service Officer initiated patrols on the beach or water immediately adjacent to the beach, 28 foot patrols, three 911 calls, 1 water rescue and 1 missing person call.

Community Service Officers / Code Enforcement

The Department's seven part-time CSO's conducted community patrols of beach, parks and schools, and commercial and residential areas. They assisted Law Enforcement personnel with several vehicle crash investigations, fingerprinting on Tuesdays and Thursdays, the issuance of RV parking permits, sea turtle / light inspections, fireworks and beach law education, a community open house at the Police and Fire Departments, the Summer Beach Bash, and the Marco Island Police & Fire Youth Academy.

Community Service Officer Rodriguez instructed CPR at the recent Florida Association of Code Enforcement Officers' annual conference in Naples.

In June, Community Service and Law Enforcement personnel attended to 208 CAD (Dispatched) events classified as "Code Complaints" at 178 unique addresses. CAD events at repeat addresses included follow-up investigations.

The Department received twenty-seven (27) noise-related complaints in June, with only one occurring during regular CSO working hours. You will note that verified noise complaints, handled by MIPD Patrol Officers, are automatically followed-up with appropriate action by the Code Enforcement Unit. In June, the Code Enforcement Unit sent 14 Courtesy Notices to owners of locations with verified first-time noise violations.

Community Service Officers opened 14 cases in May, and closed 123. Community Service Officers often close cases opened in prior months once compliance has been obtained.

The next Code Magistrate Hearing is August 11, 2015 at 3:00 p.m. – with 17 cases tentatively scheduled.
