As we entered the month of May, the coronavirus (COVID-19) was still at the forefront of the operations of the Marco Island Police Department. We continued to closely monitor the situation within the County, State, the United States and globally by being part of different planning cells and information sharing platforms. We kept personal protective equipment procedures in place to keep the responding officers and the public safe. Under the direction of Governor DeSantis's Executive Orders, Florida moved into full phase 1 of the Safe. Smart. Step-by-Step. Plan for Florida's recovery, which included partnering up with Alcohol Beverage Tobacco (ABT) and Department of Business and Professional Regulations (DBPR). 

Detective Bureau Monthly Report May 2020

INVESTIGATIVE SUMMARY:

Self-Initiated Reports:

DCF – Ongoing custody battle for children. Contact was made with DCF and the allegations were *unfounded*.

Welfare Check – Report of an elderly man potentially being neglected and abused. The allegations were investigated and were *unfounded*.

Suspicious Circumstances – MIPD was notified by Parks and Recreation about a concerning post that was made on their Facebook page. The source of the post was discovered and investigated. An outside agency did a threat assessment of the source and found them not to be a threat.

Information – Report from an insurance adjuster regarding property damage to a residence under foreclosure. Report requested for documentation purposes only for the insurance file. Detective wrote a report to assist road patrol units.

Cases Closed by Detective Bureau

Stolen Vehicle – Vehicle was rented in February of 2020 and was never returned. After working with the Pembroke Pines Police Department, the vehicle was located, and a subject was arrested. *Closed by Arrest*.

Suspicious Incident – Woman was found lying down by the Goodland Bridge and made allegations that she was a victim of a battery. A detective conducted the investigation and the woman elected to not have a criminal investigation into her claim. *Case Inactive*

Stolen Jewelry – A ring was reported stolen in 2018, and the case was suspended. This month, MIPD was contacted by the victim advising the ring was found while searching the home. *Case unfounded*.

Sexual Battery – Completed investigation as all parties were identified locally. The State Attorney refused to file charges. Both victim and suspect were juveniles. *Case Exceptional*.

Sexual Battery – After extensive investigation and assistance from an out of state partner agency, this case was closed. All parties were identified, and the State Attorney refused to file charges. Both victim and suspect were juveniles. *Case Exceptional.*

Medical Emergency/Death – Received a report from the Medical Examiner's office ruling on a medical emergency call. The decedent had a medical emergency in the waters of the Marco River. Subject died four days after this incident while under medical care. Medical Examiner report received.

Grand Theft Auto - Received notice from the State Attorney that they would be dropping charges for a Grand Theft Auto arrest. The State Attorney did not believe they could prove beyond a reasonable doubt that an acquaintance of the victim took the vehicle without permission. The suspect and victim are known. *Case Exceptional*.

Domestic Violence Battery / Violation of No Contact Order – Detective Bureau arrested male suspect who fled the scene after committing a battery and violation of injunction on his estranged wife on the day prior. *Closed by Arrest.*

Verbal Dispute – South Collier Blvd – MIPD mediated a verbal dispute where an elderly man with dementia made inappropriate remarks to a female. Records checks were conducted by detective to ensure there were no prior sex offenses or registrations. Family members took custody of the elderly man. *Information Report*

Follow-Up Reports from Patrol:

Retail Theft – A suspect was seen on camera stealing a necklace box from a local boutique store. Through a Detective's follow-up investigation, the suspect was identified and found to have a prior conviction for retail theft. A warrant request was sent to the State Attorney's Office for their arrest.

Grand Theft – Swan Drive – Unknown suspect(s) removed expensive fishing poles. Case Active.

Grand Theft – Bald Eagle Drive – Unknown suspect(s) intercepted a mailed check and cashed it for \$1,845.96. *Case Active*.

Suspicious Circumstances – South Collier Blvd – MIPD received a suspicious report regarding a woman staying in Marco Island who disappeared. Hotel surveillance footage indicated she left on her own. Case Active.

Death Investigation – Kendall Dr – Initial missing person call resulted in the discovery of the decedent who had died from an apparent earlier undiscovered medical emergency. *Case is active pending results from the Medical Examiner*.

Missing Child – Marco Island - Detectives followed up with the Child Abuse Hotline providing information regarding parent that lost a child in the care/custody. *Information Report*.
