INTRODUCTION

The Marco Island Police Department and the Community Service Unit have been proactive in their mission to protect Sea Turtles throughout Sea Turtle Nesting Season which began on May 1st. Community Service Officers Lindenmuth, Dodd, and Warder have been working hard to ensure Sea Turtle lighting compliance on beachfront properties, to help reduce the amount of hatchling disorientations this nesting season. Community Service Officers Ferraro and Citarella recovered an injured Osprey and had it transported to the Conservancy. The Marco Island Police Community Service Unit received their new beach patrol vehicle, Polaris #200, which CSO Dodd utilized to help tow in a disabled jet ski to the beach and ensure the safety of all passengers on the vessel. The MIPD worked hard to keep our community safe and clean Memorial Day weekend with increased beach, marine, and traffic enforcement. On Memorial Day we recognized the ultimate sacrifice our nations veterans have made for our freedoms to gather with our families and loved ones.

Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our Department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements. The below chart signifies the logged hours that have been devoted to the particular assignments by the Reserve and Auxiliary Officers.

Detective Bureau Monthly Report

May 2021

INVESTIGATIVE SUMMARY:

Cases Closed by Detective Bureau

Domestic Battery by Strangulation – A detective took a walk-in complaint regarding a battery by strangulation. The suspect was located and subsequently arrested. Upon the suspect's release, he violated a court ordered domestic violence injunction and was arrested again.

Civil Case – An allegation of stolen property between a homeowner and property manager, was found to be a civil issue after more evidence was uncovered.

Retail Theft – A report of stolen expensive wine from a grocery store was filed and the suspect's photograph was disseminated in hopes of generating a lead. The case was placed into inactive status until an identification is made.

Stolen Firearms – Two firearms were reported stolen this month with no leads. Serial numbers for the firearms have been entered into FCIC/NCIC in hopes of generating a lead. The case was placed into inactive status until a FCIC/NCIC hit is reported.

Grand Theft Auto – a car theft investigation from 2020 resulted in the identification of a suspect. The case was submitted to the State Attorney's Office with a juvenile pickup order. Charges were not approved. SAO declined charges.

Grand Theft – Items stolen were sporting goods (golf clubs and fishing gear) from a condo storage room. There were no witnesses or surveillance available. The items did not turn up in a search of pawn shop records, so case is inactive.

Follow-Up Reports from Patrol:

String of Vehicle Burglaries and Stolen Vehicle – On 05/10/2021, the City sustained a series of overnight vehicle burglaries and stolen vehicles. All of the victims left their vehicles unlocked, and the stolen vehicles had the keys left inside. The police department took a total of 9 vehicle burglary reports and 6 stolen vehicle reports. The suspects are believed to be a group of juveniles from Pinellas County that multiple agencies are working together to suppress.

Unlawful Computer User – A complaint was made that the victim's Snap Chat was hacked, and a nude photograph was disseminated. Investigation ongoing.

Baker Act / Risk Protection Order – Detective Bureau conducted an extensive follow-up investigation so that a risk protection order could be obtained for a subject that threatened suicide with a firearm.

Death Investigation – a decedent was located in a residence after postal carrier noticed mail not being removed from the mailbox at a residence.

Self-Initiated Reports:

Sex Offender City Ordinance – A sex offender was found to be staying at a local hotel. After making contact with the hotel staff and the sex offender, he was asked to leave City and did so.

Cyberstalking with Credible Threat – An arrest was made for a juvenile suspect who was texting threatening messages along with photographs of himself armed.

Operation Medicine Cabinet – Three initial reports for the disposal of prescription medications turned into secure medicine drop box at MIPD.





