SIGNIFICANT CASE INFORMATION/INCIDENTS:

Grand Theft 571 Diplomat Court – Victim reported an unknown suspect removed a gold bracelet from her residence. A person of interest was interviewed but no suspect(s) were ever generated. *Inactive*

Child Neglect 320 Seaview Court – An intoxicated suspect abandoned the children she was babysitting by swimming out into Gulf of Mexico in the middle of the night. When this occurred, one of the children attempted to save her and left the other child (4 Years Old) alone on the beach. The suspect never returned to the children and was later located at a condominium. The suspect was arrested and charged with child neglect. *Cleared by arrest*

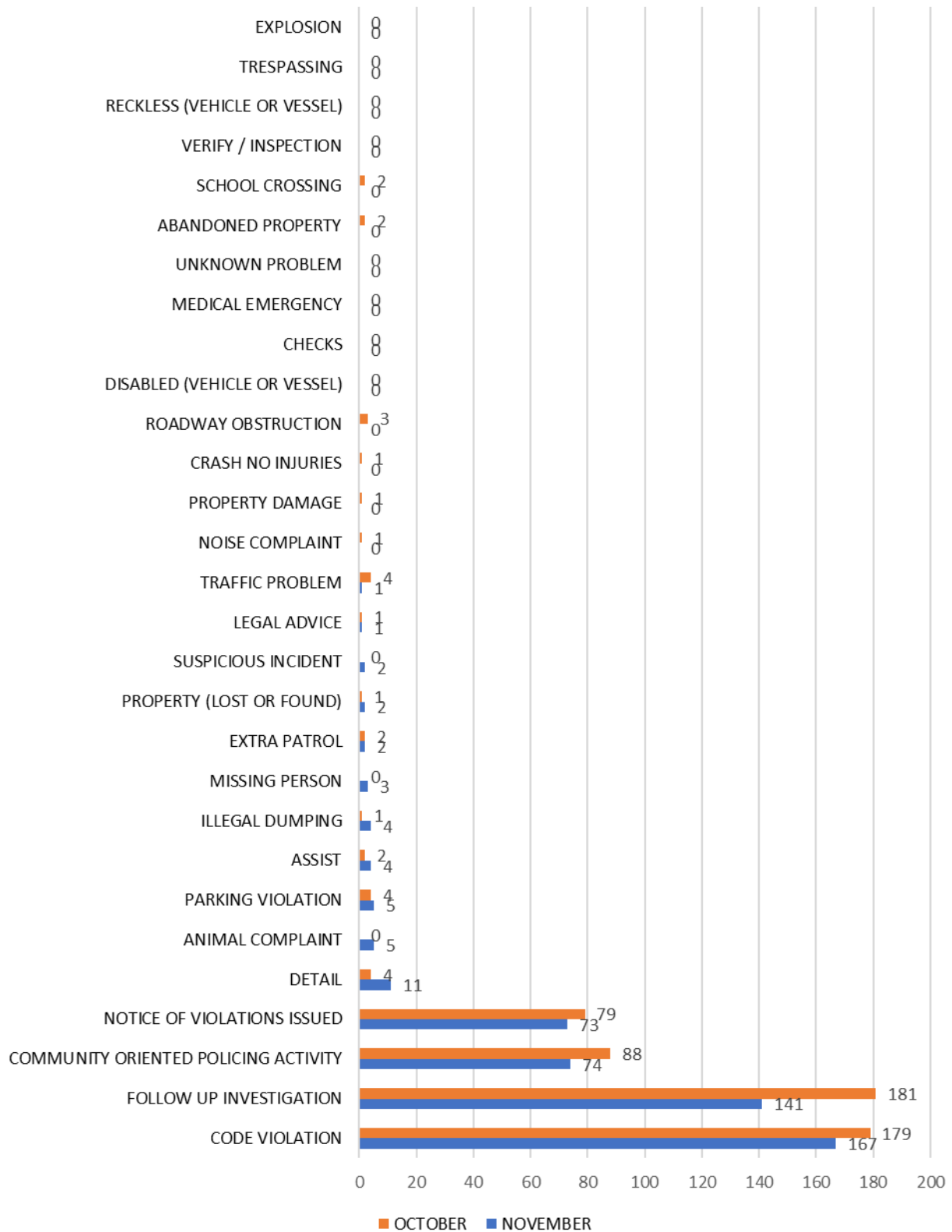
Notable events:

- Substantial social media initiative to provide education on ordinances as well as code enforcement activities.

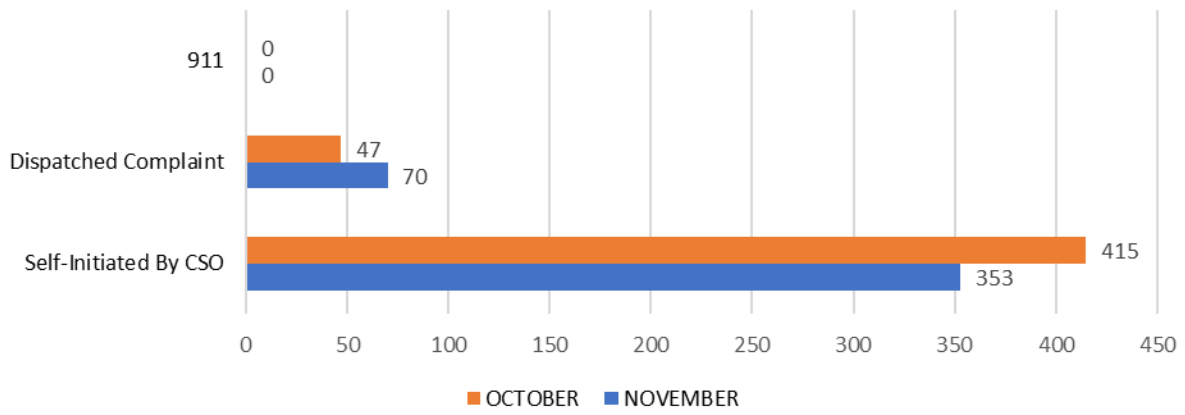

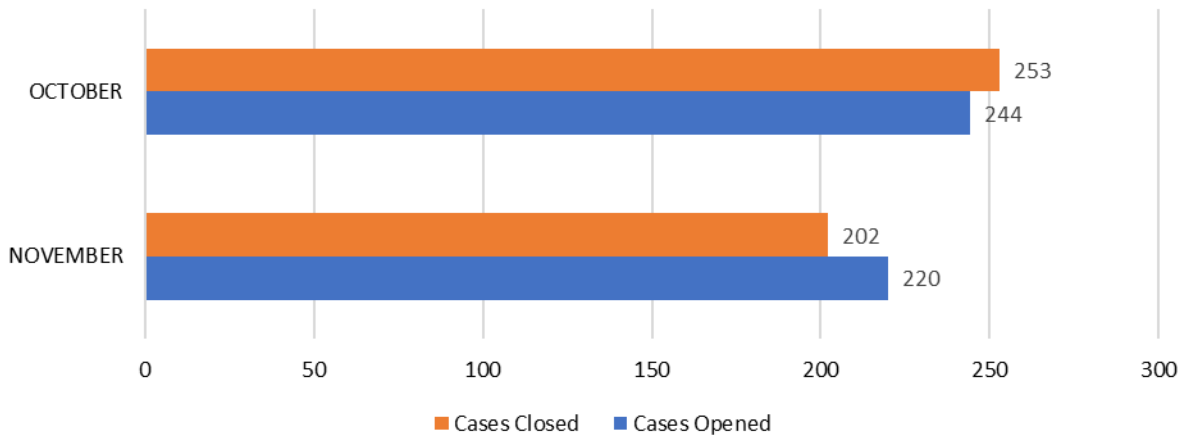
November 2019 Community Service Officer CAD Activity



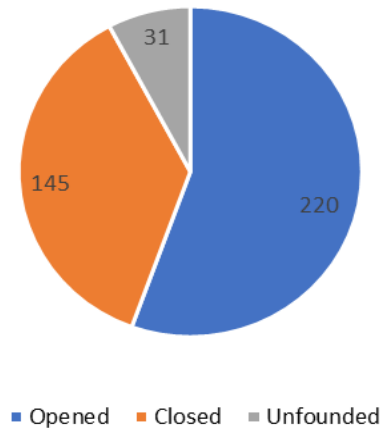
November 2019 Code Complaints by Source
