Thanksgiving is a time to pause and give thanks. All of us at the Marco Island Police Department are grateful for the strong partnership we have with our residents and the opportunity to serve this community.

We're also grateful for the positive outcome of several events that occurred this month.

During Thanksgiving week, our marine unit responded to two life threatening emergency events. Both calls answered vessels in distress with boaters either thrown overboard or vessel flooded. Quick action from our experienced marine officers averted injury and property damage; both parties were rescued. More details of these life-saving events are available in the Marine Patrol section of this report.

Earlier in the month, Officer Prigge also responded to a vessel call. This call included handling a 7-foot python that stowed away on a sailboat after a trip from Indian Key. Officer Prigge captured the snake and safely turned it over to a local wildlife handler. News of this incident made National and International headlines.

At the end of November, FDLE (Florida Department of Law Enforcement) awarded Marco Island Police Department a \$46,000 grant for the FIBRS (Florida Incident Based Reporting System) implementation project. This project is a new reporting system that helps standardize crime data across the US. Both Federal and Local Law Enforcement agencies use this crime data to identify and track trends which ultimately determine areas of focus and resource allocation. We are grateful for this funding which allows us to purchase IT equipment needed to manage data and comply with the new reporting system.

November Police Activity

Crime report:

79 incident reports were taken across the month of November: similar to the number of incident reports taken same time last year. Of the 79 reported events, 39 were criminal cases (crimes against persons, property, society, and miscellaneous crimes). 13 arrests occurred: most for criminal traffic violations (driving without a license with knowledge). Many of these arrests occurred from deploying the ALPR (license plate reader).


It's important to note that property crime during November 2021 decreased significantly versus November 2020. Last year at this time, a series of vehicle burglaries and thefts occurred on the island. The Marco Island Police Department activated several crime deterrents including a 40% increase of extra patrols this month versus same time period last year and a social media campaign that reminded residents and visitors to lock property and safely store key fobs. No vehicle property crimes occurred this month; 17 incidents occurred in 2020.


Note: Non-Criminal incidents are reports that do not have a criminal offense or are information reports. Examples include fraud cases (outside of Marco Island jurisdiction), other agency assists, lost, and found items and medical assists.

2021 vs 2020 Incident Trends

40 non-criminal incidents were reported in November. Lost and found items and fraud (occurring outside of Marco Island's jurisdiction) represented the largest amount of non-criminal reports at 20%, each. Almost 15% of reported non-criminal cases were for trespassed individuals (most cases involved trespass from businesses). The number of trespass incidents increased versus October 2021 and same time period last year.



Traffic patrol



217 traffic warnings and citations were issued in November. Violations for excessive speed and suspended licenses/unregistered vehicles accounted for over 70% of citations issued.

The ALPR system (license plate reader) remains instrumental ensuring people living and visiting the Island have valid registration and licenses. 15 driver's licenses and 2 license plates were confiscated from motorists for operating a vehicle with a suspended or canceled licenses. This statistic is comparable to the previous month. 10 drivers were arrested for knowingly operating a vehicle with a suspended license; they were transported to the Naples Jail Center.

The number of citations issued this month for running stop signs doubled vs. last month. The Marco Island Police Department reminds community and visitors that running stops signs is a leading cause for accidents. Help prevent accidents by coming to a full stop at stop signs.


November Detective Bureau Monthly Report

Investigative Summary:

Investigative cases for our detective bureau increased this month vs last year; driven in-part by an increase of battery offenses.

This month's highlight for the detective bureau concerned a case involving credible information about a wanted fugitive frequenting the area. Based on gathered intelligence, Detectives surveilled select locations and subsequently located the fugitive. The fugitive was taken into custody for the outstanding warrant. Detectives charged the fugitive with additional offenses which included knowingly driving with a suspended license, possession of marijuana (not more than 20 grams) and providing false information to a law enforcement officer while lawfully detained.

Investigative Summaries:

Cases Closed by Detective Bureau

Domestic-related Battery - The reporting person stated she was struck by her ex-boyfriend who left the scene. A suspect was identified, and a warrant request was sent to the State Attorney's Office.

Battery – An allegation of a battery on a waitress. The suspect was identified and provided an admission. The victim later decided not to press charges.

Battery - The reporting person stated she was battered by a male co-worker. Case open.

Criminal Mischief – A parked vehicle was damaged at a hotel. The suspect was identified and paid for the damage. The victim decided not to press charges.

Hit-and-run – A parked car was struck by another vehicle, which left the scene. The suspect vehicle was identified, however the victim declined to press charges.

Fraud – The State Attorney's Office approved a warrant request and filed charges against a suspect in a credit card fraud case which occurred in June of 2021. The suspect turned herself in at the Naples Jail Center.

Petit Theft – A bicycle was stolen from Mackle Park. The juvenile suspect was identified and issued a juvenile citation.

Follow-Up Reports from Patrol:

Grand Theft – An unknown person made a fraudulent copy of a victim's check and deposited it. Case open.

Death Investigations – The Detective Bureau worked four death investigations this month. These cases are with the Medical Examiner's for autopsy findings.

Suspicious Incident – Report of a condo association using surveillance equipment. Privacy concerns expressed.

Petit Theft – An unknown person stole bracelets from a retail store. Case open.

Self-Initiated Reports:

Operation Medicine Cabinet – A report was initiated after prescription drugs were removed from the public drop-off cabinet. All assorted prescription drugs were packaged and placed into MIPD property and evidence pending proper destruction.

Firearm Turn in – A citizen turned in firearms and ammunition. These items were placed into Marco Island Police Department property and evidence pending proper disposition/destruction.

November Marine Report

Marco Island waterways experienced an increase in boater traffic and anchored transient vessels during the month of November. Officer Ferris, new to the Marine Unit, along with other Marine Officers increased patrol events three-fold versus the same period last year. Marine Officers conducted more vessel safety and sanitation inspections vs. last month, including newly anchored vessels in Smokehouse and Factory Bays. All vessels followed Coast Guard regulations.

On November 23, 2021, while on routine patrol in Factory Bay, Officer Marvin came upon a sailing vessel listing and in distress. The vessel suddenly capsized sending both occupants overboard. Officer Marvin rescued both occupants, retrieving them from the waters. Afterwards, Officer Marvin proceeded to right the capsized vessel and return it to its owners. All passengers were unharmed. Four days later, Officer Marvin answered another boater distress call in the area of the Big Marco Pass. The operator of a rental boat breached an oncoming wave, swamping the vessel. Officer Marvin assisted the boater, and safely escorted the vessel back to the Isle of Capri. Officer Marvin received a letter of commendation for his quick actions for again preventing loss of life and property.

The Marine Unit also spent time this month educating boaters about the November 9, 2021 Board of Collier County Commissioners approved modifications to the boat ramp and parking at Caxambas Boat Park. Some of the modifications to the ramp include:

- Additional staffing of Caxambas Boat Park which includes a full-time Park Ranger in season and, scheduling for weekends and holidays off-season;
- Utilization of a message board on Collier Blvd. to advise when Caxambas Park is full and closed;
- Limiting the number of commercial boat launch permits annually to 180 permits;
- Increased launch permit fee for non-Collier County residents;
- Prohibiting trailers that carry more than four motorized vessels from parking in the lot but allow them to launch and leave.

- Officer Schmid completed FEMA incident command system training; application will be for crisis management.

November Reserve / Auxiliary Program Activity Hours

Reserve and Auxiliary Police Officers are unpaid volunteers who are certified by the State of Florida to perform in the law enforcement role. These officers must meet the Department's and State of Florida's annual retraining / certification requirements. Reserve and Auxiliary personnel are required to volunteer a minimum of 16 hours per month. They perform a variety of functions for our department and community which are outlined in the chart below. Particularly they assist full-time personnel at community events or special duty functions (requests for an officer to be assigned and compensated by the outside vendor) and during significant weather events such as hurricanes or flooding. Reserve and Auxiliary Officers provide an additional uniformed police presence in neighborhoods, commercial areas, schools, parks, and beaches. Once a month Reserve and Auxiliary Officers have a staff meeting to review policy changes, attend training and address planning and logistical requirements. The below chart signifies the logged hours that have been devoted to the assignments by the Reserve and Auxiliary Officers.



November Code Enforcement:

Two code ordinances were modified in November. The City of Marco Island amended Noise Ordinance sections 18-104 and 18-105 on November 1, 2021. From 7am-9pm, decibel levels must be recorded at 68 or more to be a valid violation. From 10pm to 7am, the sound must be "plainly audible" within 50ft of the property or register at 60 decibels to be a valid violation.


On November 15, 2021, a temporary exemption was granted in residential districts that allows for overnight parking on the swale until January 15, 2022.

78% of all Code Enforcement investigations resulted in an issuance of a Notice of Violation as compared to 70% the same time last year. The most significant Code Enforcement violations for the month of November were identified as waste placement on the curb, overgrown weeds, and vehicle parking.



November Code Enforcement Cases

More cases were opened this month to manage violations pertaining to placement of waste on the curb. Fewer cases were closed in November 2021 vs. the same period last year. The decrease is attributed to less complex cases appearing before Magistrate, such as parking and RV parking violations.




The three most significant violations for the month of November 2021 remain consistent vs previous months. Placement of Waste on Curb, City Code Ordinance 18-38(8) had the most violations, followed by Prohibited Parking, Ordinance 50-37; and Overgrown Weeds City Ordinance 18-36(10). November had 50% less violations this month versus last month for Placement of Waste on Curb. Increased patrolling efforts have resulted in greater community compliance.

The amount of noise complaints decreased by 54% from last month (48 complaints made in October versus 22 in November). Of the 22 calls for service, only 1 event was validated as a noise violation.

November 23, 2021 Special Magistrate Hearing Cases


37 cases were reviewed during the November 2021 Magistrate hearing: a similar number of cases to October's Magistrate hearing. Construction violations were among the largest number of cases reviewed at this month's Magistrate (32%). Construction violations included work done without a permit (7 cases), staging without a permit (3 cases), and silt fence issues (2). The number of certification of fines (liens on properties) increased; most liens were applied to properties performing work without permits.

November Beach Report

Community Service Officers (CSO) maintained a strong presence on the beach, logging in 200 hours of beach patrol. Litter and debris removal remained one of the top incidents that required beach patrol enforcement. Other prevalent infractions such as glass on beach, dogs on beach and shorebird flushing decreased 35% during November versus October 2021. To enhance beach ordinance education, Marco Island Police Department delivered social media messaging that addressed beach regulation and safety.


November Community Engagement Report



Across November, the Marco Island Police Department activated a strategic campaign to deter a seasonal crime trend: vehicle theft and burglaries. In addition to increased patrols, the Marco Island Police Department implemented a social media campaign that advised residents and visitors to lock their vehicles, homes and safely secure key fobs away from their vehicles. During November 2020, multiple vehicles were burglarized or stolen. This year no vehicles were burglarized or stolen. A combination of prevention and increased patrols kept our neighborhood safe.

The busiest shopping time of the year is also one of the most vulnerable times for people to become victims of crime. The Marco Island Police Department increased social media activity to provide shopper protection tips this holiday season. Safe holiday shopping information was also shared with the community on November 10th at Coffee with a Cop at Smith House and with the American Association of University Women on the 15th.

The Marco Island Police Department began celebrating the holiday season by participating in Toys for Tots, collecting Christmas gifts for children in our community.
