





- Dead Sea Turtle located FWCC contacted for a necropsy.


- Investigated dead birds near condo's Per FWCC a result of migration/flight into buildings.
- A substantial reduction in the request for directions/info from beach-goers was noted attributed to lower beach census (red tide).
- In 2019, so far there are 41 beach lighting violations which is up

- Requested Collier County Coordinator's participation in Magistrate's hearings to impart the seriousness
 of violations.
- Several educational projects scheduled, including CAMI occurring in beginning of the new year.
- Substantial social media initiative to provide education on ordinances as well as code enforcement activities.
