Re: September 2015 Monthly City Council Report

Due to MIPD's enforcement of vehicles blocking the sidewalk (Sec. 50-37, 1c), we have received many inquiries from Island residents regarding a lack of legal overnight parking options for visiting family and friends. This issue was previously brought to Council's attention for consideration in July 2015. Staff recommends that Council consider allowing parked vehicles to block City sidewalks between the hours of 10:00 p.m. and 6:00 a.m. versus the current 24/7/365 parking restriction.

SIGNIFICANT CASE INFORMATION/INCIDENTS:

- MIPD Officers responded to a residence on Waterleaf Court in reference to a burglary that occurred within the last few days. Victim provided a possible suspect. MIPD Detectives are investigating.
- MIPD Officers responded to an Angler's Cove residence in reference to a domestic violence call in progress. MIPD Officers arrested one male subject and transported him to Naples Jail Center.

Property & Evidence

No collections were made from Operation Medicine Cabinet in September.

The total inventory for the Property and Evidence section through September 30, 2015 is 3,951 logged items with a total quantity of 11,760 items.

During the month of September, the section also completed a uniform refresh and new lightweight uniforms for all officers.

Beach Patrol

In September, there were 91 unique events that included 10 foot patrols, 3 community events, 1 Code Violation and 85 Police or Community Service Officer initiated patrols on the beach or water immediately adjacent to the beach.

Community Service Officers / Code Enforcement

The Department's part-time CSO's conducted community patrols of the beach, parks, schools and commercial and residential areas. They assisted Law Enforcement personnel, conducted fingerprinting on Tuesdays and Thursdays, oversaw the issuance of RV parking permits, and conducted beach law education. Captain Baer hosted a local meeting with Collier County Code Enforcement and Waste Management to improve local communications, education and compliance on refuse and recycling-related activities.

In September, Community Service and Law Enforcement personnel attended to 279 CAD (Dispatched) events classified as "Code Complaints" at 245 unique addresses.
