

**MARCO ISLAND POLICE DEPARTMENT
LAW ENFORCEMENT SPECIAL DETAIL AGREEMENT**

THIS AGREEMENT, entered into this _____ day of _____, by and between the Marco Island Police Department, of Marco Island, Florida, hereinafter referred to as "MIPD" and _____ hereinafter referred to as "CONTRACTOR," both of whom shall be referred to as the "Parties."

WITNESSETH:

WHEREAS, the Contractor desired to obtain special Law Enforcement/CSO (Community Service Officer) Services at: _____ for the purpose of special details to be identified throughout the year on Marco Island, Florida, and

WHEREAS the MIPD hereby agrees to provide such security, law enforcement, and traffic control services as provided herein;

NOW, THEREFORE, in consideration of the sums hereinafter set forth and for other good and valuable considerations, the receipt and legal sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

1. For the purpose above, the MIPD shall provide to the Contractor, _____ Police Officers/CSO's per shift to the location captioned above, for the hours designated of _____ to _____ on _____ dates(s).
2. **In order to provide the most effective service and to enable the Department to plan and staff the detail accordingly, you must provide a comprehensive description of the event, including expectations, anticipated problems, projected attendance, unique hazards, potential traffic or pedestrian issues, plainclothes / uniform, as well as patrol vehicle and vessel requests. Failure to provide a detailed description could cause delays in the processing of this agreement:**

3. Such law enforcement Officers/CSO's shall perform normal law enforcement and traffic duties to provide for the health and security of persons in the immediate area of the above captioned event or locations(s).
4. At all times pertinent to this contract, the law enforcement Officers/CSO's shall be assigned by and remain under the control of the Office of Marco Island Police Department. Ownership and maintenance of equipment used in Special Details are the responsibility of the Marco Island Police Department and the assigned Officer.
5. The Contractor will remit payment to the City of Marco Island within 20 days of invoice date. The Contractor shall issue one check for all services contained within the invoice. The Contractor may not reimburse Officers directly.
6. The Contractor hereby agrees to indemnify the Police Department against any and all claims against the City of Marco Island or the Marco Island Police Department arising out of the use of the certified law enforcement Officers/CSO's, from whatever source or cause, excepting only the negligence of the Chief of Police or his Police Officers/CSO's.
7. The parties agree that the services provided for herein are not a guarantee of the health and safety of the patrons attending the above-captioned event, but it is the provision of regular law enforcement/ CSO services commonly supplied by the Office of the Marco Island Police Department to the citizens of Marco Island, Florida according to policies established by the Chief of Police.
