### **KEEP YOUR DAY SAFE:**

#### 1. Idle Speed No Wake Zones\* are:

- ALL interior waterways, canals and bays of the Island.
- In or on all waters of the Gulf of Mexico within 750 feet offshore of all beaches
- Within 300 feet of the beach adjacent to the S.R. 951/Jolley Bridge
- Operation of a vessel at a safe distance from all swimmers in the beach area is required at all times

\*Idle Speed No Wake is defined as the minimum speed required to maintain steerage.

### 2. Navigating the Waterways:

U.S. Coast Guard "rules of the road" apply to all navigational channels. Marco Island channels are marked with the standard RED, triangular signs and the GREEN, square signs using the conventional "red-right-returning" system.

- 3. Drinking While Driving-Operation of a Boat: is prohibited.
- **4. Regulating Safety:** All boats must comply with United States Coast Guard Regulations.

- **5.** Registering Vessels: All boats must be properly registered and documented.
- **6. Mooring Restrictions:** Mooring to or damaging a navigational marker is prohibited.
- 7. Anchoring Restrictions: Anchoring or any other activity that interferes with navigation in channels is prohibited.
- 8. Discharging to State Waters: Discharge of untreated sewage is prohibited in Florida waters. Seek a pump-out station.
- 9. Personal Flotation Device (PFD) of proper size are required to be onboard for every vessel occupant and one throw-away device per boat; children under 6 years must wear a PFD while underway on any vessel less than 26 feet.
- is used for distress calls and is monitored for initial contact by other vessels and shore stations. CHANNEL 16 is also used for hailing dockmasters your arrivals and departures to and from marinas. CHANNEL 27 can be used for automated Radio Checks and CHANNEL 40 has weather the information. \*If you have a Digital Service Calling (DSC), radio must be wired to boat GPS so USCG knows your position in an emergency.

# BASIC U.S. COAST GUARD EQUIPMENT REQUIREMENTS

- 1 PFD per passenger and 1 throwaway per boat
- Sound device: horn, whistles for vessels under 39.4 feet; larger vessels must have a bell with clapper not less than 7.9 inches base diameter
- Fire Extinguisher
- Vessel Distress Signals day/night flares
- Navigational lights
- Certificate of Registration and State numbering in plain block letters, numbers not less than 3 inches in height affixed to each side of forward half of vessel.

### PUMP OUT FACILITIES

Discharge of untreated sewage is prohibited in Florida waters; please utilize the sewage pump out facilities offered locally.
