NOTE 1: Reclaimed water is priced at 40% of Potable Water rate (\$4.49 per 1,000 gallons times 40% = \$1.80) for all customers with the exception of customers with properly permitted privately-owned retention lakes or holding tanks that will accept Reclaimed Water at the Utility's request. Reclaimed water fees for those accounts are priced at 30% of the Potable Water rate (\$4.49 per 1,000 gallons times 30% = \$1.35).

NOTE 2: Effective October 1, 2007, all new customers connected to Reclaimed Water system will be charged the current Potable Water rate for twenty-four (24) months to provide for recovery of capital investment costs of expanding the Reclaimed Water distribution system.
