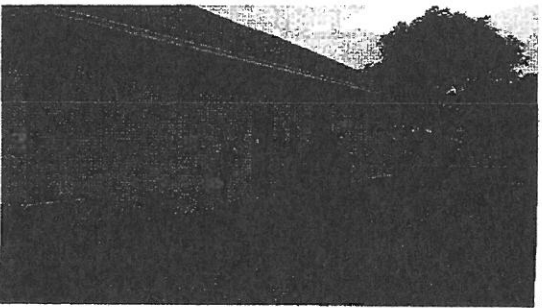

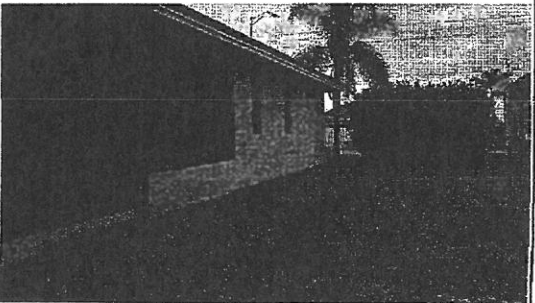
FRONT PROPERTY PICTURE 12/29/2013
